Our setting is a 26 pupil Nursery based within a mainstream school. Our children are supported in their learning by a qualified teacher and qualified Early Years Practitioners.

We are housed in a separate building with a dedicated Nursery playground. We receive Government funding so that children can have 15 or 30 hours free Nursery Education (if eligible). We are also able to offer a Lunch Club (see session times below).

Session Times

Mornings only : 8.50am - 11.50am All Day : 8.50am – 3.00pm

Morning plus Lunch Club: 8.50am - 1.00pm (extra charge of £ 5.60)

Children will need to bring a packed lunch from home if they are attending All Day or Mornings plus Lunch Club.

The school nursery only operates in term time only, 38 weeks a year.
